  - *Every application is reviewed on an individual basis*
  - *All charges in ALL states, regardless if they were dismissed or expunged.*
  - *ARC considers the following*
    - *Passage of time*
    - *Repeated and habitual crimes*
    - *Felony versus misdemeanor (nature of the crime is the primary consideration)*
    - *Compliance with court orders*
    - *Results of evaluation*
    - *How the crime relates to nursing practice and public safety*
