Upon successful completion of this course, students will be required to apply to the State of Wyoming Professional Teaching Standards Board (PTSB) for the certification. PTSB will require applicants to pay a \$100 application fee.

# Substitute Teaching Permit Requirements of The State of Wyoming Professional Teaching Standards Board

---

There are two ways to **meet the requirements** for a substitute teacher permit.

## College Credit Path

- Complete at least 60 semester hours from a regionally accredited college/university
- Successfully complete the US and Wyoming Constitution exams
- Submit fingerprints and received a clear background check
- Submit a complete application packet for a Wyoming Educator Permit

## Alternative Path

- Hold a high school diploma or GED
  - Complete at least 24 hours of school district in-service training
  - Complete at least 30 hours of classroom observation (10 hours must be completed at EACH level: elementary, junior high/middle, and high school.)
    - To obtain a Substitute Observation Hours Records Sheet (visit FC BOCES or download at this site.)
  - Successfully complete the US and Wyoming Constitution exams
  - Submit a complete application packet for a Wyoming Educator Permit
